DON'T BLAME THE COUNTRY CLUB

SRD Committee

This article is about the formation of Southglenn Special Recreation District (SRD).

In early February, we turned to our supporters to ask their opinion on how to reach the remaining 1,000 silent and/or unheard members of our community, and how to gain more momentum and cover more ground with our limited resources. With their counsel and approval, **we are changing our course**, slightly... *(A shout out to our group of contributors: Thank you for your wisdom, encouragement, creativity and support!)*

HERE IS PLAN A

We have a great many hoops that we have to negotiate successfully if the Special District is to become a reality. However, all that effort could be for naught if the Club is not available to be transferred to the Special District. Therefore, rather than put the cart before the horse, we propose to ask the SGCC Board to call a **special election in April to approve the automatic conveyance of the property** to the District in the event the creation of the District is approved by the voters in November. A “yea” vote on this ballot will accomplish a number of positive things. First, it would make clear to all that the property is, in fact, available for transfer - this proposition isn't just lofty thinking, it is real. Second, since the voters in Southglenn, assuming they respond in adequate numbers to this vote, have the ability to control the vote at the Country Club level, the vote to approve the transfer would likely succeed if we are successful in generating sufficient interest. Third, the response to this vote would give us a strong indication regarding the ultimate results of the vote in the general election and should go a long way toward generating support of our efforts and eliminating any apathy towards the formation of the District. Accordingly, we

have decided to spend some money now (that's the slight change of course mentioned above)...

In the next few weeks, you will be hearing more about this by way of flyers on your door, email messages, posts on Nextdoor, and finally **a ballot in your mailbox** asking voting stakeholders comprised of all Southglenn residents and dues-paying members of the country club, to decide on the conveyance of property. By our collective yea or nay, we either ramp up for a vigorous campaign which is Plan A. Or we move on to Plan B.

HERE IS PLAN B

The "nay" vote prevails, we disband and refund the Good Faith contributions, as stipulated, and leave the future of this property to the fates. The end.

Our fingers are crossed for a resounding **yea in this special election**. This special election in April has nothing to do with your property tax, or changing the operational status of the club. But it has **everything to do with maintaining our right to have a say about the club**. We have voting power now but this will go away if we don't take action. **Decide, or someone else will be making decisions for you.** To our knowledge, there is no other

recourse to protect and preserve the property (and consequently, your own property value) when the SGCC no longer has the capital to do it for us. **We cannot blame the SGCC. They've sounded the alarm, more than once.** Currently, they are shouldering weak membership, the resignation of their long-time reliable general manager, as well as the sudden resignations of two long-standing board members.

IF WE FORM A SPECIAL DISTRICT, WHAT'S IN IT FOR ME?

SRD Committee

This is THE question most frequently asked. The answer is: The possibilities are limited mostly by our own vision.

The formation of a Special District will accomplish several things. To begin with; it preserves ownership of the 22-acre property for Southglenn, and protects Southglenn from becoming over-developed and congested. It assures we have the financial stability to operate, maintain and enhance what we now have, into perpetuity. If none of that means anything to you, consider this:

A Special Recreation District can offer a community gathering space with social events to foster connections and reduce isolations. For example — Instead of seniors driving to the other side of I-25 or across Littleton, they could travel up the hill to meet with others. We received a note from a 47-year resident. She wrote: “What are you doing for all the senior citizens? How about 1. Socials - pot lucks, snacks. 2. Free speakers. 3. Holiday Light tours at reasonable rates (for those who don't drive). 4. Easy to do crafts or projects for other non-profit groups

- nursing homes, children, schools, library, etc. 5. Older type of movies.” But who's to say these sorts of activities should be limited to seniors. Why couldn't activities of this nature and beyond be offered to everyone? Why do we have a clubhouse in the middle of our neighborhood that sits vacant and dark far more hours than not? Why not let teens gather in the building to do homework, play games, maybe get some tutoring. Book, garden, Bunco groups (etc.) could meet here instead of stressing over last minute cleaning or pulling out extra chairs at home before company arrives. We could play poker or host football viewing events or have neighborhood potlucks.

From conversations with our residents, the SGCC used to be that hub, but our residents have long been pushed out and priced out. Reclaiming this neighborhood space will enhance our standard of living now, and improve property values while making it easier to sell our homes when we are ready to move on. Doing nothing accomplishes none of those things.

The other great reason to form a SRD is that we in *continued on page 5*

the neighborhood get to re-imagine and decide what we want to do with the land. Yes we will pay taxes but we will also finally have revenue to make improvements and make changes. Keeping a Par 3 golf course may not be the answer. Making improvements to the existing clubhouse, installing pavilions for barbecues, and adding sand volleyball courts might be the answer. The re-imagined space will be a great draw for young families to join our neighborhood and start the cycle all over. It also keeps a bit of a safe bubble around Twain, which is nice.

That's the beauty of it, the country club does not have to stay exactly the way it has always been and we as residents get to help decide what it will look like going forward – but only if 2/3 of the ballots for the special election in April vote “yea.” We will have the best of recreational amenities compared to any surrounding neighborhood... without waiting lists or membership dues for residents... without an HOA... without covenants. It will be Ours. Community. Priceless.

The decision is still ours to make...for this very narrow window of time.

WHAT DOES A “\$23,000 BUDGET SURPLUS” MEAN?

Last month SouthGlen Country Club (SGCC) ran a full-page advertisement in the newsletter indicating it “will end the calendar year with a projected budget surplus around \$23,000.” **Does this mean SGCC finished the year \$23,000 in the black?** Despite this “budget surplus,” there is a large group of residents working to create a Special Recreation District - why?

The original SGCC 2017 budget predicted a loss of \$33,000. The actual result was a loss of \$8,000. While that is \$23,000 ahead of budget (\$33,000-8,000=\$25,000, actually), **it is still a loss.** The club has lost on average \$70,000+ each year from 2010-2016. While 2017 is an improvement, it is still a loss. Much of the improvement in 2017 is attributable to fundraising efforts in September-kudos to the organizers and SGCC board for doing a great job. But a “budget surplus” is different than a profit,

and for SGCC the “budget surplus” is still a loss. Any “surplus” from fundraising is not sustainable. Simply put, the club has lost money every year since 2010 and continues to lose money.

That’s why we need to do something to protect Southglenn’s community asset.
