### CLARKSON AND DRY CREEK INTERSECTION...AARRGGHH!

At our District 1 meeting, at Southglenn Library, January 31st, I lodged a complaint to Councilwomen, Kathy Turley and Candace Moon, about making that chancy left turn at the intersection of Clarkson and Dry Creek. Left turns at this intersection are tricky because the north-south through traffic use the same lane as the left turns. I'm never sure if the car coming toward me is on-coming or left-turning.

Ms. Turley called the next morning to say that she and Ms. Moon assigned the city manager to address this and followed up with the city manager's response in a couple days. In brief, here it is:

They studied the history and found there is no pattern suggesting increased accident potential from southbound Clarkson to eastbound Dry Creek turning movement. In fact, over the past five years (2014 – 2019), there has

been only two accidents at this intersection. Both accidents were caused by a driver running a red light, and both occurred at night. They determined that there are relatively few through movements at the intersection and having the through and left-turns in the same lane actually improves the intersection operations. If, conversely, the through movement was in the same lane as the right turn lane, it would obstruct right turn movements as the through traffic would have to wait for a green light. Bottom line: This intersection stays the way it is. Unless more people speak up, we live with it.

Thanks to both our councilwomen and city manager for their service. It's nice to know they are responsive when things are brought to their attention.

But I'm still plugging for a dedicated left-turn signal.

# SEARS CLOSED, WHAT'S NEXT? \_\_\_\_

On January 31, our city council members, Candace Moon and Kathy Turley, hosted their regular District 1 meeting at the Southglenn Library. There was a short talk about The Streets of Southglenn and the closing of the Sears store. The developer did a presentation to the full city council on January 7th. The presentation is on the Centennial web page – look for the media file at item 13a of the meeting agenda.

This is a summary of the presentation. Alberta Development Partners, the original developer and owner of The Streets at SouthGlenn, recently bought the Macy's department store property and parking areas. Northwood Investors bought the Sears department store property and parking areas. Since big box stores are not working anymore, the plan is to tear down both Macy's and Sears. It appears that they plan to tear down the other buildings along Easter too. On the Sears end, they are considering building 3 buildings; one office building, and 2 apartment buildings. As designed now, the buildings will be built

right to the street along Easter. They have not decided exactly how many apartments, but they have 200 at The Streets of SouthGlenn now (which are 97% leased). They plan to build at least that many more apartments with underground parking. From the plans, the apartments look about 6 stories tall. To the north, on the Macy's end, the developers also plan to build apartments, but not right up to Arapahoe Road. They are considering putting in another park area on the north end to complement the center park (by the movie theatre).

The city's economic development team will be doing community outreach about the redevelopment. City Council will need to amend the zoning documents that regulate The Streets at SouthGlenn. The project may be considered an urban renewal project. You can email Stewart Meek (smeek@centennialco.gov) of the Centennial economic development team and ask that your email be added to the community outreach group if you want to be kept informed.





#### PARKING RESTRICTIONS ARE COMING

We all know what a treasure Southglenn is as a community to live in and how many others want to live here. It seems homes never stay on the market long once they become available for sale. Southglenn is especially attractive to freedom-loving homebuyers who don't want to live under strict HOA covenants.

Every year, we see an increase in the number of vehicles parked in driveways and overflowing to our streets — vehicles for commuting, for moving things, for storage, for getting us through the snow, classic collector vehicles, boats, trailers, RV's, plus vehicles for our driver-aged children that reside in our homes.

On February 4, 2019, City Council reintroduced consideration for additional ordinances for residential parking in response to an increasing number of complaints to the city regarding the visual and aesthetic impact of excessive parking of vehicles within the neighborhood. These included:

- · Limiting the time for vehicles parked on the street.
- Limiting the number of vehicles homeowners would be allowed to park on the street.
- Prohibiting vehicle parking on soft surfaces (such as on dirt or lawns.)

Yet, consensus on the draft regulations could not be reached by the Council. One councilman summarized that, "You just can't legislate good behavior." They agreed to revisit the issue at an undetermined future date.

Make no mistake. More laws are coming.

At present, the City has regulations restricting the on-street parking of recreational vehicles and trailers and the parking of commercial vehicles. Here are a few others about our cars already in force that you should know:

- Allow 5 feet from a driveway, (unless it's yours).
- Allow 15 feet from fire hydrant.
- Allow 20 feet from crosswalk.
- · Allow 20 feet from fire station.
- Allow 30 feet from stop sign or other traffic control sign.
- Also, Federal law requires parked vehicles to allow sufficient space for postal carriers to deliver mail.
   Many homes in Southglenn have mailboxes at the street.

No one wants more laws. So, let's do our best to comply with the laws already in place to maintain the lifestyle Southglenn offers. Happy Parking!

short periods of time. Please beware - if someone calls you asking if you are grandma or grandpa, be careful! Call your grandkids before you do anything."

Another neighbor responded with some very helpful information. AARP has a free program called Fraud Watch that is designed to help older people avoid fraud and scams. They hold free telephone town halls and people who join can ask questions of the wide variety of experts featured from the comfort of their own homes, without fear of embarrassment.

One of the most popular experts is Frank Abagnale, the con man whose story was made into the movie "Catch Me If You Can" starring Leonardo DiCaprio and who now spends his time helping others avoid being conned. Other experts are state attorneys general, tax accountants, and police detectives.

You can sign up for Free "Watchdog Alerts" at https://www.aarp.org/money/scams-fraud/. You can also look up and report scams in your area on that site. AARP periodically holds telephone town halls. If you go to https://vekeo.com and type in the word "fraud" or the word "scam" in the search box you will see the dozens of previous events and can listen to or watch any of them for free.
